

TDES Weekly Updates 2018-19 8.17.18

TDES Portal

The TDES portal opened Monday, August 6 for Year-Round schools. The portal will open Monday, August 21 for all other schools. The user interface has not changed. To access the portal go to the TDES Portal-Great Teachers & Great Leaders tab found under the TDES Homepage Quick Links. You will use your CMSD login to enter the portal.

Please note that passwords are expiring. If you receive an "invalid credential" error message when logging into the portal, please update your password on a district PC. **Do not** contact the tech department help desk. Megan Scully can assist you with this process if needed.

Accomplished Professionals

Professionals who earned a summative rating of Accomplished for the 2017-18 school year received a letter in July describing the choices available to them this year. Summative ratings are the final effectiveness rating received from eTPES, which includes TDES and SGM for most professionals. Choice 1 is taking the exemption and having a year off from being evaluated through the TDES process. Choice 2 is choosing to undergo the evaluation process for the 2018-19 school year and being eligible to **earn** the \$4000 stipend again only if they earn a summative rating of Accomplished for the 18-19 school year. The Accomplished professional must follow the guidelines outlined in the letter if choosing choice 2. **ONLY** professionals choosing to be evaluated should email tdes@clevelandmetroschools.org by **August 24** for year-round schools and **September 7** for traditional/extended schools and RSP providers. The email must be sent by the professional themselves. Forwarded emails will not be accepted. All teachers will be archived unless the email communication is received. Professionals earning an Accomplished rating 17-18 received the \$4000 stipend pay on the August 10.

Growth Plan (GP) and Improvement Plans (IP)

All professionals will either be on a Growth Plan (GP) or an Improvement Plan (IP). Paraprofessionals do not write a GP or IP. Professionals earning a TDES rating of Skilled or Accomplished will write a GP. Teachers will be placed on an Improvement Plan if they earn a TDES rating of Developing or Ineffective. The evaluator will create the plan and the teacher can provide feedback. GP/IP are due on **August 24** for year-round schools and **September 7** for traditional/extended year schools.



Walkthrough 1 (WT1)

Walkthrough 1 is due **September 14** for year-round schools and **September 28** for traditional/extended year schools. A walk-through is a short classroom visit of 5-15 minutes. Following the walkthrough, written feedback is provided through the TDES portal. The teacher may add additional evidence but is not required to. The teacher can request a post conference but the post conference is not mandatory. Please remember to email your evaluator and the TDES mailbox, tdes@clevelandmetroschools.org if your WT1 is not completed by the due date.

TDES Evaluator Think Tanks (formerly Boot Camp)

Back by popular demand is the TDES Evaluator Think Tank (formerly Boot Camp). The name has been changed but the concept will be similar. We will be offering a morning and afternoon session (in most cases) prior to each TDES event. The sessions will be the same so plan on attending only one. Focus will be on the process around the Plan, rubric components, calibration, and building professional Improvement development which can be used during the 100 minutes. All evaluators should plan on attending the first session on August 28 from 8:00-10:00 AM or 3:30-5:30 PM at East Professional emailing Center, room 224. The next Think Tank will **September 11**, from 3:30-5:30 at East Professional Center. Please note there is only an afternoon session available. The focus will be evaluating MD/Autism classrooms and library media specialists. Presenters will include members of the special education department as well as the library media department. Continuing Contracts

Continuing Contract Applications are now being accepted for 2019-2020 school year. The deadline to submit is September 17, 2018 by 5:00 PM. Professionals that apply for a continuing contract **must** be evaluated this year even if the earned an Accomplished rating 17-18.

TDES for New Evaluators Training

All new evaluators must attend new evaluator TDES training prior to evaluating CMSD teachers. The next training session will be September 12 from 9-4 at East Professional Center. Register by emailing Megan Scully.

TDES for New Teachers Training



New teachers are required to have six hours of TDES training prior to being evaluated. Training sessions will be offered on August 21, September 5, or September 26. Teachers should select one session only. Training will held at East Professional Center from 9:00-4:00. Register by emailing Megan Scully, megan.scully@clevelandmetroschools.org. Please confirm your new teachers have attended TDES training before beginning their evaluations. New teachers may need assistance calling in to the sub center.

TDES for New RSPs Training

New RSPs are required to have 3 hours of TDES training prior to being evaluated. RSPs are related service providers including, nurses, psychologists, therapists and school counselors. Training for new RSPs will be **August 31** and **September 20** at East from 9:00 –12:00. RSP's should register for only 1 session. Please register by emailing Megan Scully, megan.scully@clevelandmetroschools.org. New classroom teachers should not attend this session. It is tailored to RSPs only.

TDES for New Paraprofessionals Training

New paraprofessionals are required to have 3 hours of TDES training prior to being evaluated. Training for new paras will be **September 7** at East Professional Center from 9:00–12:00. Please register by emailing Megan Scully.

OTES Training

OTES certification is required to evaluate teachers. All CMSD evaluators must take three days of OTES training and test in a proctored environment. OTES training is offered at the ESC in Independence on **August 28-30** and **September 11-13**. Please log-in to your ODE SAFE account to register for training. OTES renewal certification must also be taken in a proctored setting. For renewals, please use the link below to register with the Office of Professional Development for testing date and times OTES/OPES Assessment Registration Link.

OPES Training

OPES certification is required to evaluate all administrators. Principals must take two days of OPES training and test in a proctored environment. OPES training is offered at the ESC in Independence on **August 22-23** and **October 3-4.** Please log-in to your ODE SAFE account to register for training. OPES renewal certification must also be taken in a proctored setting. For renewals, please use the link below to register with the Office of Professional Development for testing date and times <u>OTES/OPES Assessment Registration Link</u>.
