TDES Coordinator's Special Notes

TDES Portal

If you have not already done so, please log in to the TDES portal and make sure you are able to access your evaluation. To access the portal go to the CMSD TDES page then to the Great Teachers & Great Leaders portal found on the right site of the page. You will use your CMSD login to enter the portal.

Building assignments are updated by HR. Transfers will be completed by HR and should appear in TDES the following day. Principals are able to assign other evaluators. Please remember GP and IP will need to be assigned as well.

TDES School Teams

The Principal and the CTU representative should work together to jointly determine the TDES team for the school each year. The TDES team is asked to support TDES and SGM implementation for the building. They are expected to provide PD on TDES and SGM and answer questions from the staff. Growth and Improvement Plans

All CMSD teachers and RSPs are on either a Growth Plan (GP) or Improvement Plan (IP) for 16-17. Paraprofessionals do not have to write a GP. Overall Accomplished teachers must complete a GP, even if they are not being evaluated. Improvement Plans are currently being assigned and Accomplished teachers TDES will be archived. New teachers can complete the GP even if they have not had TDES training yet. You do not have to have a conference scheduled to start your Growth Plan. Improvement Plans will be assigned in TDES once the portal opens. Information on both plans can be found on the TDES webpage. Growth and Improvement Plans are past due.



TDES for New Evaluators Training

All new evaluators must attend new evaluator TDES training prior to evaluating CMSD teachers.

TDES for New Teachers Training

New teachers are required to have six hours of TDES training prior to being evaluated. Please send new teachers to the September 26 PD. Training will be at East from 9:00 – 4:00. Please register using the TDES calendar. Please confirm your new teachers have attended TDES training before beginning their evaluations. New teachers may need assistance calling in to the sub center.

OTES Training

OTES certification is required to evaluate teachers. All CMSD evaluators must take three days of OTES training and test in a proctored environment. OTES renewal certification must also be taken in a proctored setting. Please contact Cheryl Shelton to schedule your proctored certification test.

For other OTES training dates and times, please log in to your <u>SAFE account</u> and search STARS (keyword OTES) to register. New dates have been added for OTES and OPES assessments for the month of September. <u>Click here</u> for more information and to view the available testing dates. OPES Training

Certification is required to evaluate administrators. The OPES certification test must be taken in a proctored setting at East. Please contact Cheryl Shelton to schedule your proctored certification test.
