Once you have obtained all required documents, completed the registration form, and your child does not require any special education or language services, you may visit any neighborhood school or the Office of Student Assignments to enroll your child on any business day.

No appointment is necessary but be mindful that you may experience some delay at peak times of the day or prior to the start of the school year.

Only the parent or legal guardian of the child may complete the registration process, and all certified court orders pertaining to guardianship and custody of the child must be presented at the time of registration.

If your child has a current Individual Education Plan (IEP), Multifactorial Evaluation (MFE), you must contact the Office of Special Education to enroll your child:

The following items are required for each student you are enrolling:

- Birth Certificate
 - As one of the following:
 - Certified Copy
 - Passport
 - Birth Letter

- Custody Papers (originals with court stamp and judge's signature are required at registration)
 - As one of the following:
 - Guardianship
 - Custody
 - Divorce Decree/Shared Parenting
 - Journal Entry
 - Grandparent Affidavit
 - Power of Attorney

- Parent/Guardian Identification
 - As one of the following:
 - Driver License
 - State ID

- Immunization Records (shots)

- School Records
 - As one of the following:
 - Withdraw Slip
 - Last Report Card
 - Transcripts (unofficial/official, grades 9-12)
 - Home Schooling Documentation
 - IEP/ETR/MFE
 - 504 Plan

- Proof of Residency
 - As one of the following:
 - Home Owner's Mortgage
 - Bank Statement
 - Valid Signed Lease (must match state ID)
 - Pay Stub
 - Utility Bill (gas, electric, phone, cell phone)
 - Public Agency Award Letter
 - Bank/Credit Card Statement
